BRONWYN AMBROGETTI

Principal, Hunter Community Legal Centre

Bronwyn has worked at a senior level in community legal centres where support is provided to those experiencing financial hardship, social disadvantage, housing issues, domestic or family violence, discrimination and other legal and social issues. She has been the Managing Solicitor of the Hunter Community Legal Centre for the past 8 years and prior to that she was the Managing Solicitor of the Central Coast Community Legal Centre.

Bronwyn has organized programmes around community legal education and law reform activities relevant to the needs of the centres' disadvantaged clients. She has mentored numbers of students who have done placements at the community legal centres where she has held management roles. She is also a regular presenter at CLC conferences – both state and Federal.

Bronwyn completed her legal education at Macquarie University and after being admitted to practice worked for several firms in the Hunter prior to commencing her CLC roles.



SUZANNE DELBRIDGE

Director, Delbridge Forensic

Suzanne is a Director of Delbridge Forensic Accounting, and is a Fellow of Chartered Accountants, Australia and New Zealand.

Suzanne specialises in the valuation of equity and businesses of all sizes, the investigation of transactions and quantification of losses, and the structuring of settlements to achieve effective outcomes

SENIOR JUDICIAL REGISTRAR TRACY FLINTOFF

In 2001 Tracy was admitted to practice in Australia and New Zealand. She practised in New Zealand until 2004 when she moved to Port Macquarie, NSW to take up a position as solicitor with Stacks the Law Firm.

In 2007 Tracy established Flintoff Lawyers, based in Port Macquarie and later expanded to Newcastle. Tracy sold her practice in 2013 when she was called to the Bar.

As a solicitor Tracy was an accredited specialist in family law, ICL, appeared as solicitor advocate and on a variety of legal aid panels including family, care and protection, domestic violence, mental health and crime. She was appointed an external panel practitioner for Department of Communities and Justice NSW. Tracy was the President of the Mid North Coast Law Society from 2005 – 2007.

In 2013 Tracy was called to the Bar and practiced predominately in family law and complex care and protection, with rooms in Newcastle Chambers and Frederick Jordan Chambers. After a brief stint back in NZ at the Christchurch Bar for 2020, Tracy moved to the Northern Rivers, NSW.

In August 2021 Tracy was appointed Senior Judicial Registrar with the Federal Circuit and Family Court of Australia at Lismore.
